Every estate planning package includes the following:

- (1) Virtual or in person estate planning consultation with Attorney, Orly Reznik.
- (2) Document delivery via email (secure client portal available upon request)
- (3) Summary letter explaining estate planning documents.
- (4) Follow up consultation to review document drafts prior to signing (for trust clients only)
- (5) One round of document revisions before final signing appointment.<sup>1</sup>
- (6) Reznik Law estate organizer/digital asset organizer (and trustee handbook for trust clients).
- (7) Signing appointment at Reznik Law's Cary office.
- (8) USB drive with entire file and scanned versions of signed documents.
- (9) Post signing checklist of steps to take once documents are signed.

### *Will Package Pricing*

Will Package: \$1600 (per couple) \$1200 (individual planner)

**Package includes:** 2 Wills, 2 General Powers of Attorney, 2 Health Care Powers of Attorney, 2 HIPAA Releases and 2 Living Wills, post signing checklist and consultation guidance to minimize probate, assistance with car title transfer paperwork.

**Who is the package right for?** This package is best suited for individuals or couples who have a traditional asset composition, and want to leave assets (or may want to leave assets) to minors in a trust for a short period of time, or outright to adults.

Will Package (business owners or complex planning needs): \$2150 per couple, \$1750 individual planner.

**Package includes:** 2 Wills, 2 General Powers of Attorney, 2 Health Care Powers of Attorney, 2 HIPAA Releases, 2 Living Wills, Transfer of death business certificate

**Who is the package right for?** This package is best suited for individuals or couples who own a closely held family business and want to leave assets (or may want to leave assets) to minors in a trust for a short period of time.

## ***Unfunded Family Trust Package Pricing***

\$2,100 - \$2500 per couple

**Package includes:** 2 Wills, 1 joint family trust, 2 General Powers of Attorney, 2 Health Care Powers of Attorney, 2 HIPAA Releases and 2 Living Wills

**Who is the package right for?** This package is best suited for couples who own their assets jointly with rights of survivorship, have a traditional asset composition, and want to leave assets (or may want to leave assets) to minors in a trust for any length of time. This package is designed to avoid probate, but avoid the hassle and need to lifetime trust funding.

## ***Funded Revocable Trust Package Pricing***

*Revocable Living Trust Packages starts with the simple probate avoidance trust and may be subject to additional costs if add-on provisions are needed.*

Probate Avoidance Revocable Living Trust Package: \$3,100 - \$3,450 per couple, \$2,400 individual planner.

**Package includes:** 2 Pour Over Wills, 2 General Powers of Attorney, 2 Health Care Powers of Attorney, 2 HIPAA Releases, 2 Living Wills, 1 Joint Revocable Living Trust (or 2 separate revocable living trusts) with standard continuing trusts for children and other heirs, Certificate of Trust, Assignment of personal property to trust, 1 deed transferring property to trust, 2 disposition of remains forms, memo for distribution of personal property, and memo regarding funding the trust, **follow up consultation to review drafts together.**

**Who is the package right for?** This package is best suited for individuals or couples who have estates valued at under \$9 million dollars, would like to avoid probate, need to leave assets in trust for longer periods of time, have a blended family, need to make multiple specific distributions, have a complex assets composition or own multiple properties or properties in multiple states.

## ***Add-on Trust Pricing***

Deed Recording: County and third-party recording charges paid by Reznik Law to record new deed. Typically, this cost is \$38, but may be higher, depending on the County.

Additional Deeds: \$225 drafting charge, plus applicable County recording fees

Marital Trusts: \$550 drafting charge. This trust structure ensures that surviving spouse is provided for, but surviving spouse cannot change the ultimate asset distribution.

Disclaimer Tax Planning: \$550 drafting charge. This trust structure creates flexibility and post mortem estate tax planning options is someone doesn't have a taxable estate now, but may at the time of passing.

Additional Sub-trust: Ranges from \$450-\$1,500 depending on the terms of the sub-trust and drafting time required.

Special needs planning: Additional drafting charge of \$500-\$2500 depending on type of documents needed. The higher end is for standalone special needs trust when done as a separate plan and not part of revocable living trust planning.

Business planning: cost varies depending on needs. Typical needs include:

1. Review of operating agreement and bylaws, update operating agreement and bylaws to provide succession planning provisions, *call for pricing*.
2. Draft stock certificates, membership certificates resolutions authorizing transfer to trust, and special business provisions for trustee, *price range, \$150-\$275 per business, call for pricing*.
3. New LLC Creation: \$600 extra drafting charge, + \$127 filing fee charged by the North Carolina secretary of state.
4. Operating Agreement- \$2,000 and up. This varies greatly depending on the business structure and terms to be contained in the operating agreement.

### ***Irrevocable Trust Pricing***
